Photographs can be taken at the December 12, 2017 Association Representative Council meeting or by appointment December 13, 14 or 15th at the CCEA offices, no later than 4:30 p.m. The Elections Committee will publish the photograph and typed campaign statement, up to 150 words, in the CCEA Elections Newsletter. Excess words will be deleted.

**The statement must:** 1) Be informational in nature; 2) Contain factual statements; 3) Be limited to objective facts. **The statement may:** 1) Not include subjective statements; 2) Not contain testimonials; 3) Not include explicit or implicit references to or comparisons with other candidates.
