

## Summer School Contact Units Clarification

Teachers may accrue Contact Units (CUs) for teaching at a District-approved credit retrieval Summer School as referenced in the *Professional Growth System (PGS) Reference Guide* (page 13). Credit retrieval summer school programs approved for



CU accrual are through the Curriculum and Professional Development Division (CPD), Nevada Learning Academy (NVLA), Education Services Division\*, or Apex Learning Site-Based Summer Credit Recovery\*\*. Educators teaching summer school are paid at the District supplemental rate of \$22.00 per hour and may accrue a maximum of 30 CUs per column movement in this category.

Summer School	<ul><li>15 CUs per session of summer school</li><li>Maximum 30 CUs</li></ul>	Educators/licensed professionals will be paid \$22/hour for teaching at a District- approved credit retrieval summer school and also receive CUs.

\*Teaching during the summer on an extended contract, such as with ESY, ZOOM, or some Education Services Division Summer Programs (Corrections and Choice Schools) does not accrue CUs as the educator is being paid his/her contractual rate of pay.

\*\*As it is not based upon a standard number of hours per session, teaching Apex Learning Site-Based Credit Recovery will accrue CUs at the rate of one (1) CU for every six (6) hours.

Educational activities that do not meet the above criteria may not accrue CUs within the Summer School category. Other summer activities, such as School-Based Tutoring in Core-Content Areas or Extracurricular Activities, may be eligible for CUs as outlined in the *PGS Reference Guide* (pages 11 and 14).

School-Based Tutoring in Core- Content Areas	<ul> <li>One (1) CU for each 180 minute time period</li> <li>Maximum 30 CUs</li> <li>Title I, Tier I and Title I, Tier II Schools:</li> <li>Maximum 50 CUs</li> <li>In Title I, Tier I and Title I, Tier II Schools, an educator/licensed professional may be paid for tutoring outside the contractual workday and also receive full CUs.</li> </ul>	Educators/licensed professionals may deliver instruction one-on-one or in small groups of students. Instruction might include supporting, accelerating, or remediating students before or after school.

Activity	Contact Units	Description and Limitations
Educators/licensed professionals who coach a sport, advise, or coordinate an extracurricular club or activity	<ul> <li>Maximum 30 CUs         <ul> <li>*The maximum 30 CUs may accrue through the fall, winter, spring, and summer seasons.</li> </ul> </li> <li>Any educator/licensed professional who is compensated for coaching/advising a sport, extracurricular club, or activity may accrue CUs at the one-half rate.</li> <li>Title I, Tier I and Title I, Tier II Schools:         <ul> <li>Maximum 40 CUs</li> <li>*The maximum 40 CUs may accrue through the fall, winter, spring, and summer seasons.</li> </ul> </li> <li>Any educator/licensed professional who is compensated for coaching/advising a sport, extracurricular club, or activity may accrue CUs at the one-half rate.</li> </ul>	The educator/licensed professional must be on the school's approved student activity or coaching list. CUs accrue for direct contact time for coaching/advising students in the area of an extracurricular assignment. Sports and activities which occur throughout the year that include more than one season may count toward CUs. For example, a football coach who is compensated during the fall football season may earn one-half CUs. If he/she also conducts summer weight training with the football players for no compensation, he/ she may accrue full CUs.
