- \* 4:30 PM President Vikki Courtney calls the meeting to order.
- \* ARC approves the agenda for the night
- \* ARC approves the minutes from the December ARC meeting.
- \* Yolanda Lowry & Karl Bryd
- \* We are aware of the issues with pay; we were not the only bargaining unit that was affected by this error by the district.
- \* This is an issue that CCSD will have to work through
- \* CCEA has sent a demand letter to the district that demands the district pay teachers by the 31st.
- \* CCEA is not capable of lending people money; this would violate federal law if we did.
- \* We will continue to pressure the district until they pay educators what they are owed.

- \* The issues with the new HCM system have also affected school budgets. This is why some schools have delayed their SOT meetings until the district gets them accurate numbers.

- \* We have introduced two ballot initiatives, a 3% increase on gaming and a 1.5% increase on the Local School Support Sales Tax (LSSST)
- \* Why did we target these two taxes?

- \* The gaming tax because this can be used for other areas of the state budget. We need this because the state has rising costs across several areas and if we don't purpose funding for them we could see education funding reduced to help cover these shortfalls.
- \* The LSSST, the reason we targeted this tax is because it is the only tax in the state that will generate the amount of money we need state wide and that MUST go directly to education because of SB 543 passed last legislative session.
- \* We are entering a critical moment in this campaign and we need every single one of our leaders to stand together to support this plan and get colleague to sign the Strategic Horizons pledge sheet.
