

CCEA COMMITTEES

The CCEA President shall appoint all committee members and chairpersons with the confirmation of the Association Representative Council. Each Standing Committee should promote and support the diversity that is representative of CCEA's membership. Standing Committee members shall be members of the Association Representative Council and possess voting privileges in the ARC.

Each Standing Committee shall have a purpose, procedures, and a chairperson to conduct their business.

Budget Committee

The Budget Committee is responsible for the oversight of the operating budget of the association. The Committee meets monthly with the CCEA Treasurer and Director of Finance and Administration. The Treasurer presents the Budget Committee's report to the CCEA Executive Board and to the AR Council at their monthly meetings.

Bylaws and Policy Committee

The Bylaws Committee is responsible for recommending revisions of the CCEA Bylaws for adoption by the AR Council.

The charge of this committee is to use the information presented to the committee through the Executive Board and Associated Representatives or members, to determine if the bylaws are addressing the needs of CCEA's membership. If they are not, develop language and recommendations for changes. The Bylaws committee should work in tandem with the Policy committee and ensure alignment of both, to our Mission and Vision.

The Policy Committee is responsible for proposing new policies and updating current policies of the Association and presenting them to the AR Council and Executive Board for action.

The charge of this committee is to use the information presented to the committee through the Executive Board and ARC, to determine if the policies are addressing the needs of CCEA's membership. If they are not, develop language and recommendations for changes. Work in tandem with the Bylaws Committee and ensure alignment with CCEA Mission and Vision.

Elections Committee

The Elections Committee is responsible for conducting all elections and ratification of the Collective Bargaining Agreement. The Committee proposes the Standard Elections Procedures for adoption by the AR Council.

Member Engagement Committee

The member engagement committee is responsible for brainstorming and helping implement new ideas on how to raise levels of member engagement. This would include social engagement ideas.

Member Rights Committee

The Member Rights Committee is responsible for determining whether grievances will proceed to arbitration.

Negotiations Committee

The Negotiations Committee is responsible for negotiating the contract with the school district. The Committee seeks member input to set its priorities.

Scholarship Committee

The Scholarship Committee is responsible for determining the recipients of the CCEA Scholarships. The Committee proposes scholarship criteria for adoption by the AR Council. Voluntary funded by CCEA members and donors.

Special Education Committee

The Special Education Committee is responsible for addressing the issues, needs, and concerns of the membership working under the Student Support Services Division through research, training, and communication of information.

CCEA/CCSD Sick Leave Pool Committee

The committee is responsible for reviewing all requests for additional sick days from the sick leave pool. The committee is managed by the Governance Executive Assistant. Committee members include the Chair – President and/or Vice President, CCSD Payroll, CCSD EMR, THT Nurse, and 3 CCEA Members

Government Relations Committee - ELECTED Position

The Government Relations Committee is responsible for increasing member awareness of the potential influence CCEA has that will impact the political arena.

Work with the CCEA AR Council, Executive Board, and staff to meet the Mission and Vision of the organization. Work with leaders of all parties to engage on issues that cross party lines.
